

MINUTES OF THE 30TH ANNUAL GENERAL MEETING HELD ON THURSDAY 10TH MAY 2001.

1. **Present:** Mr W McCreath, President, and 32 members.
2. **Apologies:** L Macaskill, A Ross, E Carmichael, T Tyler, B Thomas, M Copley, K Copley,
3. P Mackie, M Patterson, M Rowell, J Harris, M Stone, M McDonald, and K Home Robertson.
3. The minutes of the 29th AGM were read, approved and signed.
4. **President's report:** Mr McCreath submitted his report to the meeting, and it was adopted. (Copy on file).
5. **Treasurer's report:** Mrs Mole submitted the audited accounts to the meeting. The surplus for the year was £110, an improvement on last year. The membership stood at 69, down from 73 last year. The accounts were adopted. (Copy on file) Mrs Mole recommended that the subscription and the table money remain the same.
6. **Competition Secretary's report:** Mr Drysdale reported a successful year. He felt that the earlier start had been a success. He commented that the scoring on aggregate nights remained a problem, as there were always a lot of mistakes, and it could take up to 4 hours to balance. He suggested a fine of 200 points be imposed for mistakes. A new scoring method had been used for the Pivot Teams (details on file), and he suggested this could be adopted for all competitions.

Mr Drysdale's suggestions were then discussed:

1. Fine on mistakes on score cards – this was not approved.
 2. New scoring method – the members thought it a good idea for teams, but agreed to leave the committee to make the final decision

Club starting time – after much discussion it was decided to revert to 7.30 next season, as some members had great difficulty in getting there for 7.15. A French made a plea for directors to keep tables moving. Mrs P Thomas reminded the meeting that a previous AGM had recommended playing a maximum of 24 boards on Thursday nights.

Mrs McConnachie asked if it would be possible to distribute a list of members with telephone numbers at the beginning of the season. This was approved.

Competition Secretarys Report 2000/2001

We have had ⁶⁹~~76~~ members playing in 70 Club nights this season and generally Club nights have been well supported. We have played in 11 different Competitions and produced 20 different names on the trophies, which indicates that members are competing well and no one individual is dominating the winners enclosure except possibly in the teams Competitions when Glen Emery was in all 3 winning teams.

- My Thanks go to all the directors and scorers of competitions. This is not the easiest of jobs and it can be taken a bit for granted. Aggregate scoring continues to be a tiresome job often taking a long time to balance. I would ask that more attention is paid to recording the scores and agreeing with your partner and opponents. I still believe that a penalty of 200 per mistake on an aggregate night would help to minimize these errors and provided you agree we could try it for next season.

There has been less complaints about club play which I partly put down to the 7.15 pm start. I know that a number of people wish to force this matter but I would remind you that in March 2000 a survey of members resulted in over 90% favouring the earlier start.

Simultaneous pairs have been fairly well supported and those that played seemed to enjoy them and both Bridge Unions and Charities benefitted from us taking part. A notable success in one

of the 'The Bobby Allow' was our President Bill McCreath and
Marguerite Robson 38th out of a field of 669 pairs.

I put an notice on the board in November last year
which I have photocopied and will hand out to you. I
shall now read it through.

I suggest we go ahead with this on Tuesday evenings next
Season but leave Thursdays as there are.

Finally handicaps. The new system basing handicaps on
two months played on Thursday evenings has been largely
successful and in the last eight years we have seen
an increase from 37% to 63% the number of people
funchy in the 45% - 55% Range. This would indicate that
handicaps are better matched to how people have actually played.
However there is a downside which was pointed out to me
recently that some low handicap players may become over
aggressive on Thursday evenings, this discourages new members
and I therefore remind you that Thursday night's enjoyment
is more important than necessarily winning. It is the only
way we will encourage new members and thereby ensure the
future of the club.
