Our legal basis for processing this data is our legitimate interest as a bridge club. We use the data for the administration of your membership, the communication of information and the organisation of events.

This information will be recorded in our membership database, which is stored online in compliance with the Act. Our membership data is shared with the Scottish Bridge Union, the governing body of the game of duplicate bridge.

A limited amount of your information (name, SBU number, post town) will be listed in the SBU's database made available for use by scoring program providers and users. This is to allow the correct identification of players for scoring purposes.

Your data may be processed by Pianola/Bridgewebs/other organisations that act as Data Processors on our behalf. They may only use it for the specific purposes for which they act as our data processors and they are not free to pass this on to other organisations.

Your personal data is not passed on by us for use by any other third parties whether or not connected with bridge. Full information about our data use policies, including how you can see what data we hold about you, how you can limit its use and how you can ask for inaccuracies in data to be corrected, may be found at <https://berwickbridgeclub.co.uk/gdpr>.
